Both the Irvine Company and Time Warner Cable remain as the #1 secured and unsecured taxpayers from the prior year. Walt Disney Parks & Resorts US and So Cal Edison Company continued to hold the #2 and #3 secured tax spots. Cox Communications Inc. continued to hold the #2 unsecured tax spot, while Broadcom Corp. moved up to the #3 unsecured tax spot. Current year secured tax collections are on track to meet or exceed the FY 12/13 secured collection rate of 98.9%. This collection rate is the highest rate found recorded for the County.

This press release was revised to update the unsecured property tax list with the commonly used names of the two companies, The Boeing Company and New Albertson's Inc., versus the name on the press release dated January 24, 2014 that is only a subsidiary of the main company.
