Overview of proposed changes to the Investment Policy Statement

- Extend the maximum maturity for government debt and medium term note/corporate debt to 5 years.
- Allow single A or better credits to be purchased out to 5 years maximum maturity.
- Allow single A or better credits to be purchased for specific investments.
- Establish additional portfolios to provide for longer-term investment needs, such as OPEB.
